RULE 8351 ADMISSION TO THE DISTRICT BAR (a) Eligibility for Admission An attorney is eligible for admission to the bar of this district if the attorney: (1) is a member of the bar in good standing in Massachusetts; (2) is a member of the bar in good standing in every jurisdiction in which the attorney has been admitted to practice; and
