CHAPTER 13 SAFE HAVEN RELINQUISHMENTS Art 1149 Purpose; short title A The purpose of this Chapter is to provide a mechanism whereby any parent may relinquish the care of an infant to the state in safety, anonymity, and without fear of prosecution B This Chapter shall be known and may be cited as the "Safe Haven Law"
