**REQUIREMENTS TO DRIVE A SCHOOL BUS IN ALABAMA**

In order to maintain their school bus driver certification, school bus drivers are required to participate in a 4-hour recertification class These classes are scheduled in all school systems and are taught between January 1 and November 15 annually All bus driver certificates expire annually on December 31
